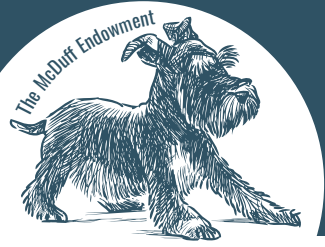




PAWS IN THE AIR
